Accomack County: Parksley Fire Station -10:00am

Heritage Center:

- Will there be enough for future storage needs?
- Will the space be climate controlled?
- Has expansion of this space been accounted for?
- How is the space being protected against catastrophic occurrences?
- If a geothermal system is being considered, be cautious of cold or hot spots.
- Noise separation appears very good for the various user groups
- Main Foyer appears to be excessive; will it be used for display & furnishings in lieu of circulation only?
- Will this be a LEED facility?
- The Free Library of Philadelphia has very generous gallery space.
- The Main Foyer should include adequate space for the display of artifacts.
- Where are the periodicals located?
- Explain extent of outdoor green space.
- A row of trees is suggested as a means of screening the rear of adjacent neighboring buildings.
- A closed circuit security system is being installed in town, and should include the area around the Library.
- How many parking spaces are anticipated as compared to the existing Library?
- Consider the use of semi/permeable pavers for storm water management.
- Gallery: A State Senator & a Delegate have initiated a bill to the General Assembly to earmark \$2M for the Department of Historic Recourses with the intention of passing a portion of that down to the local level for artifacts.
- Suggestion was made to switch the locations of the Friends Rm. with the Custodial/Storage Rm.
- Can anything be done to reduce the size of the Elec/Mech Rm. by relocating equipment to the exterior?
